

**SCRUTINIZER'S REPORT ON REMOTE E-VOTING

76th Annual General Meeting of the Members of Amrit Corp. Limited held on Tuesday, the 19th September, 2017 at 11.00 A. M. at Chaudhary Bhawan, (Near Jain Mandir), E- Block, Kavi Nagar, Ghaziabad (U. P.) -201 002.

Subject: Passing of resolutions through electronic voting pursuant to section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Amendment Rules, 2015.

Dear Sir,

1. Pursuant to the resolution passed by the Board of Directors of Amrit Corp. Limited (hereinafter referred to as **(the "Company")**) on 17th July, 2017, I have been appointed as a Scrutinizer for the remote e-voting process as mentioned under Rule 20(4)(ix) of the Companies (Management and Administration) Amendment Rules, 2015.
2. The Company engaged National Securities Depository Limited ("**NSDL**") as the Service Provider for extending the facility of electronic voting to the shareholders of the Company. The Service Provider provided a system for recording the votes of the shareholders electronically on all the items of business sought to be transacted in the 76th Annual General Meeting ("**AGM**") of the Company, which was held on Tuesday, the 19th September, 2017. National Securities Depository Limited ("**NSDL**") had set up e-voting facility on their website, <https://www.evoting.nsdl.com>. The Company had uploaded all the items of the business to be transacted on the website of the Company and also it's Service Provider to facilitate their shareholders to cast their vote through e-voting.



3. As on the cutoff date for despatch of notice of annual general meeting, there were 13474 shareholders of the Company. The Notice of Annual General Meeting and Circular for e-voting was sent through email to 1881 shareholders whose email id was made available by the two depositories and for those holding in physical form to the extent it was available with the RTA and in the physical form to 11593 shareholders.
4. The Notice sent both through email and physical form contained the detailed procedure to be followed by the shareholders who were desirous of casting their votes electronically as provided in the Rule 20(4)(iii)(A) to (C) of the Companies (Management and Administration) Amendment Rules, 2015.
5. The cutoff date (Record date) for the purposes of identifying the shareholders who will be entitled to vote on the resolutions placed for the approval of the shareholders was 12.09.2017. The e-voting facility was kept open from 16th September, 2017 (09.00 A.M.) to 18th September, 2017 (05.00 P.M.)
6. Pursuant to Rule 20(3)(v) of Companies (Management and Administration) Amendment Rules, 2015, the Company also released an advertisement, which was published more than 21 days in advance from the date of beginning of voting period in Financial Express, English Newspaper and in Jansatta, Hindi Newspaper both dated 23rd August, 2017. The notice published in the newspaper carried the required information as specified in the Rule 20(4)(v) (a) to (h) of Companies (Management and Administration) Amendment Rules, 2015.
7. At the end of the voting period on September 18, 2017 at 5.00 P.M. the voting Portal of the service provider was blocked forthwith. On September 19, 2017 after the annual general meeting the votes cast through e-voting facility was duly unblocked by me as a Scrutinizer in the presence of Mr. Rishabh Aggarwal and Mr. Bharat Malik who acted as the witnesses, as prescribed in sub Rule (4)(xii) of said Rule 20 of Companies (Management and Administration) Amendment Rules, 2015.
8. Particulars of all Votes cast by electronic mode have been entered in the register separately maintained for the purpose in electronic mode.

As a Scrutinizer the report of the e-voting carried by the shareholders was duly complied, the detail of which are as follows:-




All the resolutions contained in the notice dated 17th July, 2017 calling 76th annual general meeting of the Company stand passed under e-voting process with requisite majority.


